• Traffic Obstruction - Unloading on a busy street without a designated spot can cause congestion.

1. Check Your Local Borough's Requirements

Where can I place a parking suspension for moving?

Parking suspensions can be applied to: Resident bays, Pay & Display bays, Single yellow lines (subject to council approval), and Loading bays. Ensure the location complies with council rules and is as close to your property as possible.

What happens if I don't get a parking suspension?

Without a suspension, your moving van might not find space near your home, causing delays and extra costs. You could also be fined for illegal parking. Worse, the van may block traffic or cause safety issues if forced to park illegally.

Can the moving company arrange the parking permit for me?

Some removal companies in London offer to arrange the permit on your behalf, often for a service fee. However, the responsibility typically falls on the customer. It's always best to confirm with your chosen moving company before booking.

Are parking suspensions different from parking permits?

Yes. A parking permit gives ongoing permission to park in designated areas (e.g., for residents), while a parking suspension temporarily restricts access for specific dates and purposes. For moving house, a suspension is typically what's needed—not a regular permit.
